# Membership categories:

Regular Division: Anyone who has served honorably in the rank of E1 through E9 in any branch of the military, active, guard or reserve.

Veteran Division: Any officer of any branch of the military, active, guard or reserve.

Auxiliary: Anyone over the age of 18 who is related to someone who would have qualified for regular division status. That includes spouses, brothers, sisters, nieces, nephews, parents, aunts, uncles, cousins, grandkids. That included pretty much anyone related either directly or indirectly to someone who has served.

Associate Division: People who have never served but support what NCOA does. They can be politicians, business people who support veterans etc.

The following is an excerpt from the most current guidance on Cost of Living Adjustments (COLA) from a letter from the Office of the Assistant Secretary of Defense, dated November 14, 2022. This letter and more information about COLA can be found at this website: <u>https://www.ssa.gov/cola/</u>

### 2023 ADJUSTMENTS TO RETIRED/RETAINER PAY, SURVIVOR ANNUITIES AND PREMIUMS

The following Cost-of-Living Adjustments (COLAs) are effective December 1, 2022, based on the increase in the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) through the third quarter calendar year 2022. The term "retired pay" includes retainer pay and the term "members" includes former members. Where applicable, the appropriate section of United States Code (U.S.C.) is cited.

## **COLAs for Retired Pay**

1. The retired pay COLA for those who first became members of a Uniformed Service before September 8, 1980, is specified according to the effective date of their retirement, as follows:

Retired Pay Based on		
Rates of Pay Effective	Percent Increase	10 U.S.C. Authority
Before January 1, 2022	8.7 percent	1401a(b)(2)
January 1 - December 31, 2022	7.0 percent	1401a(c)

 The retired pay COLA for those who first became members of a Uniformed Service on or after September 8, 1980, including those members covered by the High-3 or Blended Retirement System (BRS), is specified according to the effective date of their retirement, as follows:

Retirement Effective:	Percent Increase	10 U.S.C. Authority
Before January 1, 2022	8.7 percent	1401a(b)(2)
January 1 - March 31, 2022	7.0 percent	1401a(d)
April 1 - June 30, 2022	4.4 percent	1401a(d)
July 1 - September 30, 2022	1.2 percent	1401a(d)
October 1 - December 31, 2022	0.0 percent	1401a(d)

3. The retired pay COLA for those who first became members of a Uniformed Service on or after August 1, 1986, and also elected to receive a career status bonus under the provisions of Sections 322 (as in effect before January 28, 2008) or 354 of Title 37 U.S.C. is specified according to the date of their retirement, as follows:

Retirement Effective	Percent Increase	10 U.S.C. Authority
Before January 1, 2022	7.7 percent	1401a(e)
January 1 - March 31, 2022	6.2 percent	1401a(e)
April 1 - June 30, 2022	3.9 percent	1401a(e)
July I - September 30, 2022	1.0 percent	1401a(e)
October 1 - December 31, 2022	0.0 percent	1401a(c)

# January 2023 Security

### Tax Scams — How to Report Them

To help the public recognize and avoid abusive tax schemes, the IRS offers an abundance of educational materials. Participating in an illegal scheme to avoid paying taxes can result in imprisonment and fines, as well as the repayment of taxes owed with penalties and interest. Education is the best way to avoid the pitfalls of these "too good to be true" tax scams.

### **Reporting Tax Scams**

### **Phishing Scams**

Phishing is a scam typically carried out through unsolicited email and/or websites that pose as legitimate sites and lure unsuspecting victims to provide personal and financial information.

Report all unsolicited email claiming to be from the IRS or an IRS-related function to <u>phishing@irs.gov</u>. If you've experienced any monetary losses due to an IRS-related incident, please report it to the <u>Treasury</u> <u>Inspector General Administration (TIGTA)</u> and file a complaint with the Federal Trade Commission (FTC) through their <u>Complaint Assistant</u> to make the information available to investigators.

How Do You Report Suspected Tax Fraud Activity?

- <u>State ID Theft Resources</u> State information on what to do if you or your employees are victims of identity theft.
- Employers and tax professionals should notify states of any disclosures of W-2s or other identity information by emailing <u>StateAlert@taxadmin.org</u>.

### **Report Suspected Tax Law Violations**

Submit Form 3949-A, Information Referral online PDF if you suspect an individual or a business is not complying with the tax laws. We don't take tax law violation referrals over the phone. We will keep your identity confidential when you file a tax fraud report. You won't receive a status or progress update due to tax return confidentiality under IRC 6103.

### Tax fraud includes:

- False exemptions or deductions
- Kickbacks
- A false or altered document
- Failure to pay tax
- Unreported income
- Organized crime
- Failure to withhold
- Failure to follow the tax laws

He then served in the US Naval Reserves between 1982-2006, retiring as a Master Chief Petty Officer (E-9), and he deployed twice for Iraqi Freedom between 2002-2003 and 2005-2006.

**Ron Kohl**, *Treasurer/Trustee*: Ron served in both the Air Force as a Tech Sergeant, and the Army as a Staff Sergeant before he retired. He also served in law enforcement and is committed to helping locals avoid fraud and scams.

**Bud Cordes**, *Knight Advisor*: Bud Cordes was a USAF Tech Sergeant who retired after 20 years of service in 1978. He served in Vietnam between 1968-1969.

**Kris Stevens**, *Trustee*: Kris served in the Coast Guard as a Machinery Technician 2nd class, E-5, from 1975 to 1979. He served the majority of his enlistment at a small boat rescue station at the northwest tip of the Washington Olympic peninsula.

**Ken Wilson**, *Vice Chair*. Ken served in the United States Navy for 4 years and was honorably discharged as n E-5 Boiler Tech. He served on four ships during his time. The first three he was part of the decommissioning party and he ended his career on board the USS Camden (AOE-2).

**David Haines,** *Trustee:* David served 24 years in the navy and Navy Reserve and 7 years in the Air Force Reserves where he deployed to Qatar in 2007-8. He achieved the rank of E-6.
